

## Holland Township Parks and Recreation

### Facility and Grounds Fee Schedule

#### COMMUNITY CENTER RENTAL FEES:

**Meeting Room:** (23'7" x 17' or 400 sq. ft.) for small, informal group meetings. Groups of 20 or less, (not to be rented as a separate room for private functions).

**Member Rate:** \$35.00 per hour (one hour increments)

**Non-member resident:** \$40.00 per hour (one hour increments)

**Non-member non-resident:** \$45.00 per hour (one hour increments)

**Lounge:** (Room capacity – 68 persons- 34' x 35' or 1190 sq. ft.)

**Meetings:** same rates and rules apply.

**Private functions\*:** includes use of kitchen, meeting room, foyer and patio

**Member Rate:** \$300.00 for 4 hours. (each additional hour \$75.00)

**Non-Member resident:** \$350.00 for 4 hours. (each additional hour \$85.00)

**Non-Member non-resident:** \$375.00 for 4 hours. (each additional hour \$95.00)

**Foyer/Lobby:** (21'3" x 39'8" or 850 sq. ft.)

**Gym:** (Room capacity - 674 persons-78'6" x 59'6" or 4670 sq. ft.)

**Private functions\*:** includes use of kitchen, meeting room and foyer. (ie. Wedding, sports banquet, etc.)

**Member Rate:** \$100.00 per hour.

**Non-member resident:** \$125.00 per hour.

**Non-member non-resident:** \$150.00 per hour.

**Team or league use:** \$40.00 per hour (2 hour minimum rental)

(multiple rentals of four (4) consecutive weeks – 1 day per week. Must provide a current Certificate of Insurance with application.

**\*Private functions: Rented in minimum of four (4) hour blocks. \*\*A nominal fee of \$35 per hour will be charged for setting up and clean-up.**

Township approved community or civic groups, i.e. boy/girl scouts, will be allowed meeting space (if and when available). Fee for use will be waived in lieu of community services to be provided. Such services will be decided between the group and the acting management of the Community Center

Fifty (50%) of the total rental fee plus a refundable **security deposit of \$150.00** is required to hold requested date for event and must be paid at the time of application. **A copy of renter's homeowner's insurance policy must be presented with application.**

**A cancellation fee of \$150.00 will be retained when a cancellation is made within thirty (30) days of scheduled event.** Failure to receive remainder of unpaid fee thirty (30) days prior to scheduled event will be treated as a cancellation and will result in forfeiture of facility use and our retention of the cancellation fee.

<b>Non-member resident:</b>	<b>\$25.00 per hour with three hour minimum</b>
<b>Non-member non-resident:</b>	<b>\$30.00 per hour with three hour minimum</b>

- The above rates apply to anyone wishing to reserve one of the given area's for a private affair.
- Members and Township residents may use these area's at any time available without fee, but cannot reserve unless fee is paid.
- Anyone who had paid the fee to reserve shall have preference of scheduling.
